✓ With reference to your abovenoted letter, I beg to request you to kindly send attested copies of previous correspondence (if any) between your office and this office in respect of creation of first post of Lecturer in Sanskrit Department of the College with effect from 22.8.67.

It may, please, be noted, in this connection that in terms of this Directorate circular no. 1930(76)-C dt. 30.5.66, prior approval of D.P.I., West Bengal in respect of creation of teaching posts in the college prior to the session 1969-70 was necessary in order that the incumbent of the post might be eligible for the benefits of the improved scales.

✓ It may please be clarified why Sanskrit classes for P.U. Arts and P.U. Commerce students were held separately during the session 1966-70, even though the enrolment in Sanskrit in each of P.U. Arts and P.U. Commerce *classes* did not exceed 20 during these sessions.

This Directorate is of opinion that the classes should have been held together.

✓ It may, kindly, be noted further that the statements of work-loads in Sanskrit for the sessions 1966-70 furnished with your letter under ~~xxx~~ reference are not clear on certain points. The matter was discussed with your representation, Sri J.N. Pathak calling at this office on 7.4.70. Clear statements of work-loads in Sanskrit for the said sessions may please be
