### **EMERGENCY CYCLONE SHELTER AT SURENDRANATH EVENING COLLEGE, 24/2 MG ROAD, KOLKATA-09**

In reference to the directives of Department of Disaster Management and Civil Defence, Govt. of West Bengal, vide order no: 97-PSDM&CD/2021 dated 20/05/2021, Surenranath Evening College is offering emergency shelters from 24/05/2021 to 27/05/2021 to avoid casualties and damages due to the upcoming cyclonic storm "YAAS".

The college authority has decided to extend supports towards the probable cyclone victims around our college. Despite the infrastructural and management difficulties, we are bound to lend our supports as follows:


- i) Maintaining all the COVID19 protocols and regulations, we will be able to give shelters only for 350 (Three hundred and fifty) people.
- ii) Only class rooms will be provided for shelters.
- iii) Proper sanitization of the premises will be performed.
- iv) Washrooms (separate for male and female) will be provided. Cleanliness and proper hygiene will be our priorities.
- v) Face mask will be provided to maintain COVID19 guidelines.
- vi) In case of emergency, Oxygen facility will be provided.
- vii) Electricity and drinking water will be provided to the evacuees as far as CESC and KMC continue to supply.
- viii) Dry food will be provided to the evacuees.
- ix) Premises will be used as shelter for the above said period only.


